After consideration on the merits, the Committee recommends the following:

HB14-1319 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend reengrossed bill, page 6, line 27, strike "23-18-201." and
- 2 substitute "23-18-202 FOR STUDENT STIPENDS."
  
- 3 Page 8, line 4, strike "AND".
  
- 4 Page 8, before line 5 insert:
  
- 5       "(V) UNDERGRADUATE OR CERTIFICATE PROGRAMS THAT HAVE A
- 6 HIGH COST PER STUDENT; AND".
  
- 7 Renumber succeeding subparagraph accordingly.
  
- 8 Page 9, line 7, strike "MAY" and substitute "SHALL".
  
- 9 Page 9, line 8, after the period add "IN DETERMINING THE AMOUNT OF
- 10 FUNDING, THE COMMISSION SHALL CONSIDER PROGRAMS THAT HAVE A
- 11 HIGH COST PER STUDENT, INCLUDING BUT NOT LIMITED TO PROGRAMS IN
- 12 THE FIELDS OF LAW, BUSINESS, SCIENCE, TECHNOLOGY, ENGINEERING, AND
- 13 MATHEMATICS."
  
- 14 Page 12, after line 6 insert:
  
- 15       "(8) (a) NOTWITHSTANDING ANY PROVISION OF LAW TO THE
- 16 CONTRARY, AN INSTITUTION MAY USE FUNDING PROVIDED PURSUANT TO

1 THIS SECTION AS FINANCIAL ASSISTANCE FOR IN-STATE STUDENTS TO  
2 REDUCE THE STUDENT'S SHARE OF IN-STATE TUITION, AS DEFINED IN  
3 SECTION 23-18-102.

4 (b) FOR AN INSTITUTION THAT USES FUNDING RECEIVED PURSUANT  
5 TO THIS SECTION TO PROVIDE FINANCIAL ASSISTANCE FOR IN-STATE  
6 STUDENTS, "STUDENT'S SHARE OF IN-STATE TUITION" HAS THE SAME  
7 MEANING AS SET FORTH IN SECTION 23-18-102, LESS THE AMOUNT OF ANY  
8 FINANCIAL ASSISTANCE AWARDED TO THE STUDENT PURSUANT TO  
9 PARAGRAPH (a) OF THIS SUBSECTION (8)."

10 Page 26, after line 21 insert:

11 "SECTION 5. In Colorado Revised Statutes, 23-18-102, **amend**  
12 (12) as follows:

13 **23-18-102. Definitions.** As used in this article, unless the context  
14 otherwise requires:

15 (12) "Student's share of in-state tuition" means, EXCEPT AS  
16 PROVIDED IN SECTION 23-18-303 (8), the amount of total in-state tuition,  
17 less any amount paid on behalf of the student as a stipend.

18 **SECTION 6.** In Colorado Revised Statutes, 23-20-112, **add** (3)  
19 as follows:

20 **23-20-112. General powers of the board - repeal.**  
21 (3) (a) NOTWITHSTANDING ANY PROVISION OF LAW TO THE CONTRARY, AN  
22 INSTITUTION GOVERNED BY THE BOARD OF REGENTS MAY USE FUNDING  
23 PROVIDED PURSUANT TO SECTION 23-18-303 AS FINANCIAL ASSISTANCE  
24 FOR IN-STATE STUDENTS TO REDUCE THE STUDENT'S SHARE OF IN-STATE  
25 TUITION, AS DEFINED IN SECTION 23-18-102.

26 (b) FOR PURPOSES OF PARTS 1 AND 2 OF ARTICLE 18 OF THIS TITLE,  
27 FOR AN INSTITUTION GOVERNED BY THE BOARD OF REGENTS, "STUDENT'S  
28 SHARE OF IN-STATE TUITION" HAS THE SAME MEANING AS SET FORTH IN  
29 SECTION 23-18-102 LESS THE AMOUNT OF ANY FINANCIAL ASSISTANCE  
30 AWARDED TO THE STUDENT PURSUANT TO PARAGRAPH (a) OF THIS  
31 SUBSECTION (3)."

32 Renumber succeeding sections accordingly.
